PROPOSED STOPPING UP OF FOOTWAY – COBBETT STREET, SW8

(Note: This notice is about stopping up a part of the footway of Cobbett Street so that it ceases to be public highway and becomes part of the redeveloped land at the junction of Cobbett Street and Dorset Road. Objections may be made – see paragraph 7)

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Lambeth propose to make an Order under section 247 of the Town and Country Planning Act 1990 (“the Act”), entitled the London Borough of Lambeth (Stopping-Up of Highways) (Cobbett Street) Order 202*.
2. The proposed Order would authorise the stopping-up of an area of the footway on the south-east side of Cobbett Street (at its junction with Dorset Road).
3. If the proposed Order is made, the stopping-up of highway would be authorised only to enable the development described in the Schedule to this Notice to be carried out, in accordance with the planning permission granted under Part III of the Act to the Council of the London Borough of Lambeth on 26th September 2019 under reference 17/05993/OUT.

PROPOSED DEVELOPMENT AT: South Lambeth Estate, Dorset Road London SW8 1AH. Construction of a new building (4 to 6 storeys) on the corner of Dorset Road and Clapham Road to provide 30 residential units (use Class C3) with associated parking and landscape works: improvements to the ground floor of Wimborne House including extension and conversion of the existing Caretakers room to provide a community room (use Class D1) together with works to provide entrance and refuse store. (Wimborne House to be retained).
