The Council of the London Borough of Lambeth, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984(a), and of all other powers thereunto enabling, hereby make the following Order:-

Citation and commencement

1. This Order may be cited as the Lambeth (Clapham "L") (Parking Places) (No.* Order 202* and shall come into force on *** 202*.

Interpretation

2. (1) In this Order "the Order of 2010" means the Lambeth (Clapham "L") (Parking Places) (No. 1) Order 2010(b).
- (2) Unless the context otherwise requires, any expression used in this Order which is also used in the Order of 2010 shall have the same meaning as in that Order.
- (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.

Revocation of designation of parking places

3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into force of this Order, the designation by the Order of 2010 of the parking places numbered 26 and 455 therein, the designation by the Lambeth (Clapham "L") (Parking Places) (No. 3) Order 2017(c) is hereby revoked.

Designation of parking places and application of the Order of 2010 thereto

4. (1) Each area on a highway comprising the length of carriageway of a street specified in column 2 of Schedule 1 and 2 to this Order and bounded on all sides by a white line marking is designated as a parking place.

(2) The reference in this Article to a white line marking shall be construed as a reference to the white line marking (either broken or continuous) provided for in Schedule 7 to the Traffic Signs Regulations and General Directions 2016(a) or, if applicable, authorised by the Secretary of State by virtue of section 64 of the Road Traffic Regulation Act 1984.

(3) The provisions of the Order of 2010 (other than Articles 3, 16 and 41) shall apply to the areas designated as parking places by this Order as if in those provisions any reference to a parking place included a reference to an area designated as a parking place by this Order and as if any reference to Schedule 4 to the Order of 2010 included a reference to Schedule 1 to this Order, as if any reference to Schedule 14 to the Order of 2010 included a reference to Schedule 2 to this Order.

Placing of traffic signs, etc.

5. The Council shall:-

- (a) place and maintain traffic signs indicating the limits of each parking place referred to in Schedule 1 or 2 to this Order;
- (b) place and maintain in or in the vicinity of each parking place referred to in Schedule 1 or 2 to this Order traffic signs indicating that such parking place may be used during the permitted hours for the leaving only of the vehicles specified in Article 4(2) of the Order of 2010;
- (c) carry out such other work as is reasonably required for the purposes of the satisfactory operation of each parking place referred to in Schedule 1 or 2 to this Order.

SCHEDULE 1 (see Article 4)

IN RELATION TO A PARKING PLACE REFERRED TO IN THIS SCHEDULE THE EXPRESSION "PERMITTED HOURS" MEANS THE PERIOD BETWEEN 9 A.M. AND 6 P.M. ON MONDAYS TO FRIDAYS INCLUSIVE, ANY SUCH DAY NOT BEING CHRISTMAS DAY, GOOD FRIDAY OR A BANK HOLIDAY.

PARKING PLACES IN WHICH A VEHICLE MAY BE LEFT DURING THE PERMITTED HOURS PROVIDED THE VEHICLE DISPLAYS EITHER A VALID HARD COPY LAMBETH RESIDENT'S PERMIT, A VALID HARD COPY LAMBETH CAR CLUB PERMIT, A VALID HARD COPY LAMBETH VISITOR'S PERMIT OR A VALID HARD COPY TRADE PERMIT, ISSUED IN RESPECT OF THAT VEHICLE, OR THERE APPEARS ON A HAND-HELD DEVICE AN INDICATION THAT AN ELECTRONIC VERSION OF ONE OF THOSE PERMITS OR A FLEXIBLE CAR CLUB PERMIT HAS BEEN GRANTED IN RESPECT OF THAT VEHICLE AND THE PERMIT IS VALID.
