ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14

**TEMPORARY ROAD CLOSURES FOR TELECOMMUNICATIONS WORKS CRIFFEL AVENUE,
EMMANUEL ROAD, RASTELL AVENUE, SALFORD ROAD, STERNHOLD AVENUE, TELFORD
AVENUE, TENHAM AVENUE AND THORNTON AVENUE**

1. NOTICE IS HEREBY GIVEN that to enable works to modernise telecommunications equipment to be carried out, the Council of the London Borough of Lambeth intend to make an Order the effect of which would be to temporarily ban vehicles from entering that length of:-

- (a) **Criffel Avenue** between Thornton Avenue and Salford Road (alternative routes for affected vehicles would be available via Thornton Avenue, Telford Avenue and Salford Road and vice versa);
- (b) **Emmanuel Road** which lies between Radbourne Road and Salford Road (alternative routes for affected vehicles would be available via Salford Road, Telford Avenue, Rastell Avenue and Emmanuel Road and vice versa);
- (c) **Rastell Avenue** between Telford Avenue and Sternhold Avenue (alternative routes for affected vehicles would be available via Telford Avenue, Tenham Avenue and Sternhold Avenue and vice versa);
- (d) **Salford Road** between Telford Avenue and Sternhold Avenue (alternative routes for affected vehicles would be available via Telford Avenue, Thornton Avenue and Sternhold Avenue and vice versa);
- (e) **Sternhold Avenue** between Rastell Avenue and Thornton Avenue (alternative routes for affected vehicles would be available via Thornton Avenue, Telford Avenue and Rastell Avenue and vice versa);
- (f) **Telford Avenue** which lies between Tenham Avenue and Rastell Avenue (alternative routes for affected vehicles would be available via Salford Avenue, Emmanuel Road and Rastell Avenue and vice versa);
- (g) **Tenham Avenue** between Telford Avenue and Criffel Avenue (alternative routes for affected vehicles would be available via Telford Avenue, Salford Avenue and Criffel Avenue and vice versa);
- (h) **Thornton Avenue** between Telford Avenue and Criffel Avenue (alternative routes for affected vehicles would be available via Telford Avenue, Salford Avenue, Criffel Avenue and Thornton Avenue and vice versa).

2. The bans described above would only apply at such times and to such extent as shall be indicated by the placing of the appropriate traffic signs.

3. The Order would come into force on 21st June 2021 and would continue for a maximum duration of 18 months or until the works have been completed, whichever is the sooner. In practice it is anticipated that the road closures would only apply in phases as the works progress along the roads concerned and it is anticipated that the works would take between 2 and 3 weeks to complete in each road.
