Proposed Controlled Parking Zone (CPZ) Gipsy Hill Area



Stage 1 Consultation

Dear Resident/Business

The purpose of this leaflet is to seek your views on proposals to introduce a Controlled Parking Zone (CPZ) in your area.

This proposal is in response to representations received from local residents who are experiencing parking difficulties in their area. Generally, residents feel the problem is being caused by commuters who park and complete their journey by public transport or those working in nearby businesses.

It has, therefore, been decided that the Council will carry out an informal consultation to seek your views on proposals to control parking in your area.

How does a CPZ work?

CPZs mean that only vehicles with valid permits are allowed to park in controlled roads during the operating hours. Permits will only be made available to purchase by local residents and businesses within the CPZ boundary. Illegally parked vehicles are liable to receive a Penalty Charge Notice (parking ticket).

Please see the frequently asked questions (FAQ's) sheet enclosed for more information regarding CPZs and how they work.


What are the extents of the proposals?

This area is currently being proposed as new stand-alone zone for information purposes, although it may be necessary to break the area up into a smaller zone/s upon analysing the consultation results.

Your URN is enclosed on the address sheet of this package. Please note, only one submission will be accepted per household.

What happens next?

The decision on whether or not to proceed with the next step, will be based on to the responses received during this Stage 1 Consultation.

The results of the consultation along with officers' recommendations will be presented in a report to Cabinet Members for Sustainable Transport, Environment and Clean Air. Once a decision is made you will be informed accordingly.
