

# Proposed Estate Parking Controls Paulet Road Estate (PRE)



Statutory Consultation

20 May 2022 – 10 June 2022

Dear Resident

We would like to hear your views on the introduction of additional parking controls at Paulet Road Estate (PRE).

We will be introducing parking controls to the entrance ramps and underground garage area.

Your estate is in an area where parking is now in high demand, which has led to nuisance parking by people who do not live on the estate. Having additional parking controls means the estate will be patrolled regularly by our enforcement officers.

Illegally parked vehicles are liable to receive a Penalty Charge Notice (parking ticket) or removed.

The council has limited ability to manage nuisance parking without introducing Parking Controls. The purpose of this Statutory consultation is to add additional areas to the existing Traffic Management Order (TMO) which gives us the legal powers to manage parking on our estates.

## How can I give my views?

A Notice of the Council's intentions to introduce these measures will be published in a local newspaper (South London Press), the London Gazette and posted on lamp columns in the area.

Representations for and against the proposals described in this Notice must be made in writing to: **Estate Parking, Housing Services, P.O. Objections must relate only to the elements of the scheme that are subject to this statutory consultation. All representations along with Officers' comments and recommendations will be presented in a final report to be considered by the Council. This report will set out whether the Council will introduce parking amendments across the Borough, and if so, which roads will be subject to such proposals. The Council is required to give weight to the nature and content of your representations and not necessarily the quantity. Your reasons are therefore important to us.
