Proposed Estate Parking Controls Vassall Road (VR) Lambeth

Statutory Consultation

20 May 2022 – 10 June 2022

Dear Resident

We would like to hear your views on the introduction of parking controls outside the garages adjacent to 161 Vassall Road (VR).

These garages are located in an area of the borough where parking is now in high demand. Having parking controls means the area will be patrolled regularly by our enforcement officers to ensure no one is able to park in front of the garage area.

The introduction of Controlled Parking Zones in surrounding streets has led to increase unauthorised parking by non-residents. As a consequence, residents, Lambeth contractors and even emergency vehicles have experienced problems gaining access to deliver essential services.

The council has limited ability to manage nuisance parking by people who do not use the garages without introducing Parking Controls. The purpose of this Statutory consultation is to introduce a Traffic Management Order (TMO) which gives us the legal powers to manage parking in this area.

The Traffic Management Order will bring this garage area on Vassall Road in line with other parking enforcement within your area, which already benefit from the protection of parking controls.

How do parking controls work?

Illegally parked vehicles are liable to receive a Penalty Charge Notice (parking ticket) or removed.

Where can I see exactly what is being proposed in my area?

How can I give my views?

A Notice of the Council's intentions to introduce these measures will be published in a local newspaper (South London Press), the London Gazette and posted on lamp columns in the area.

Objections must relate only to the elements of the scheme that are subject to this statutory consultation. All representations along with Officers' comments and recommendations will be presented in a final report to be considered by the Council. This report will set out whether the Council will introduce parking amendments across the Borough, and if so, which roads will be subject to such proposals. The Council is required to give weight to the nature and content of your representations and not necessarily the quantity. Your reasons are therefore important to us.
