### Dear Resident / Business

The purpose of this leaflet is to let you know the outcome of the statutory consultation carried out in August / September 2022, and to inform you of the Council's decision on the reinstatement of the Streatham Hill LTN & the proposed extension of 'M' Controlled Parking Zone (CPZ) in Palace Road & Hillside.

All representations received along with officers' recommendations were presented in a report which was considered by the Council. After careful consideration a decision has been made to proceed with making the LTN permanent and to introduce the CPZ extension to be operational Monday to Friday between 10am and 12pm(noon).

### What happens next?

The final Traffic Management Orders (TMOs), which allows the restrictions to be implemented and administered, will be published in the London Gazette and the local newspaper (South London Press) shortly.

### Implementation works

The lining and signing works will be carried out by our contractor **Ringway** on behalf of the Council. It is anticipated that the works will start the week commencing **24 October 2022** and will last approximately **1 week**, weather permitting.

Works will be carried out Monday to Friday between 7am and 4.30pm. "No Parking" cones and warning signs will be in place to indicate the areas where parking will be prohibited between 24 and 48 hours prior to work being undertaken. On the days where work is being undertaken in your street, please avoid parking where the "No Parking" cones and signage have been put in place to allow for the lining and post installation works to proceed efficiently.

Vehicles will be allowed back onto the road once the lining/post installation work is complete and where the cones and warning signs have been removed.

The Council is conscious of the disruption that this work may cause and will endeavour to keep the impact to a minimum. We therefore appreciate your cooperation and apologise in advance for any inconvenience that may be caused.

## **Do I have to pay to park in the CPZ?**

Any resident living in a CPZ who owns a car and wants to park on the public highway during the hours of control will need a parking permit for that CPZ.

Residents will also be able to buy visitor vouchers for their guests to be able to park in designated bays, or trader vouchers so that works (such as renovations or landscaping) can be done at their properties.

Any persons visiting the neighbourhood to access shops or services can make use of short-term parking provisions, which means they pay only for the time they're parked in the area.

If you park your vehicle off street on your driveway/private property you would not require a parking permit.

## **Where can I park?**

Vehicles displaying a valid Zone 'M' permit would be able to park in marked bays on the public highway within the entire Zone 'M' as shown on the plan. Check signs before parking.

## **How do I apply for a parking permit/vouchers?**

## **Pay by Phone**

For short or unplanned visits, when you may not have any visitors voucher to hand, visitors can park for up to a maximum of one hour in shared-use bays by calling, texting or using the mobile phone Pay by Phone application. ## **Who can I contact regarding the implementation of the CPZ and waiting restrictions?**

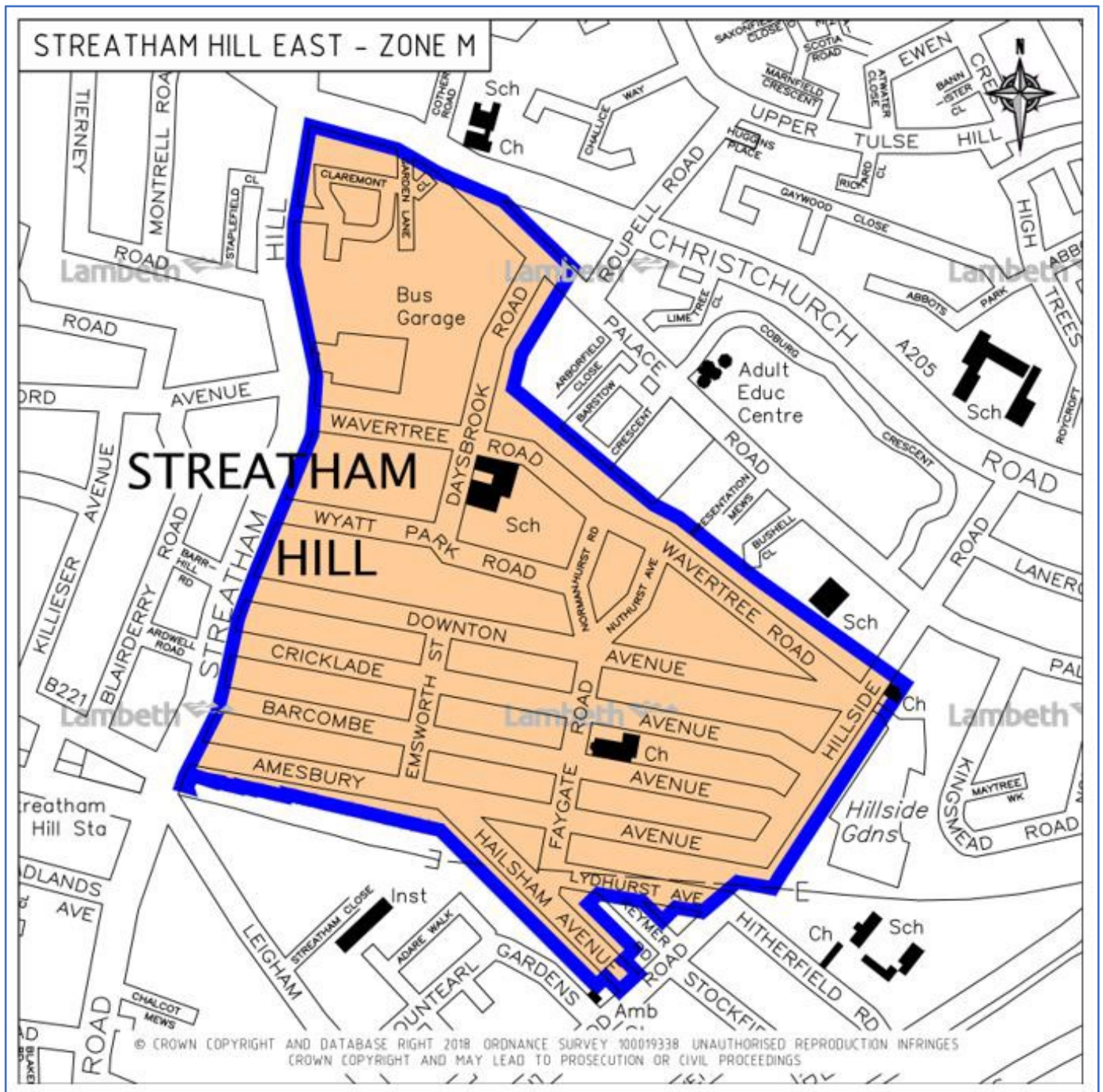

## What is the extents of the CPZ?

The extents of the Streatham Hill East CPZ (Zone M) is shown below. A valid resident or business permit in respect of this zone will allow you to park in any permit parking bay within the area.



## Streatham Hill LTN - Re-instatement information

Ringway Infrastructure Services, in partnership with Lambeth Borough Council, are collaborating together to recommission the Streatham Hill Low Traffic neighbourhood (LTN) this will help reduce vehicle speeds, traffic collisions, improving air quality, increase levels of walking and cycling in the area while supporting the local economy and positive equalities impacts.

Works will take place on Amesbury Avenue, Hillside Road, Downton Avenue, Palace Road, Rosedene Avenue, Mount Nod Road, Emsworth Road, Daysbrook Road.

### Details of the works

1. **Ringway Infrastructure Services in partnership with Lambeth Borough Council** will be Recommissioning the Streatham Hill Low Traffic neighbourhood (LTN) by reinstalling the signs and associated road markings for the LTN.

### Phasing and timings of the works

Works are programmed to be carried out from **24<sup>th</sup> October to 30<sup>th</sup> October**.

The work will be carried out **08:00 –18:00hrs Monday to Friday**, and **08:00 – 14:00hrs on Saturdays**.

- Streatham Hill LTN Recommission (24<sup>th</sup> October– 30<sup>th</sup> October)
- Issue warning notices for a 2-week period (31<sup>st</sup> October – 13<sup>th</sup> November)
- Observe a 3-days grace period to allow deliver of outstanding warning notices (14<sup>th</sup> November – 16<sup>th</sup> November)
- Commence issuance of live PCNs from (**17<sup>th</sup> November**)

While the signs will be up and active by 30<sup>th</sup> October the Penalty Charge Notices (PCN) won't be issued until **17<sup>th</sup> November** after the 3-day grace period and the 2 week notice period is over.

### Things to note

Cyclist and emergency vehicles are exempt from the modal filter if you are a blue badge holder you can apply for dispensation to the traffic filter on the Lambeth website:

If you receive and Penalty Charge Notices (PCN) you can appeal by using the contact information on the PCN or heading to Lambeth's website

Your co-operation is essential – please do not park in the areas affected by the proposed works. Warning signage and barriers will be installed in the areas affected. This will require no vehicles to be parked in the road within the working and safety zones, as indicated by cones and suspension signs.

**Any obstructing vehicles will be relocated to nearby spaces/roads.**
